Melissa Petersen will be a consistent on-site staff member to help train and guide staff, families, and students to meet guidance from OHA. Sam Schafer with Washington County Public healthy Authority is our liaison for any plans, outbreaks, and reporting that needs to be done. Staff will be trained during in-service on the proper protocols and procedures for sections 1-3. Helpful information sheets have been created to share with staff and visitors on campus. Cleaning plans have been created along with checklist for systematic disinfection of all spaces. The school will be using a student app fore health checks.
